1. Name

he name of the Charita! le "n#or\$orated %rganisation (&the C"%') is the (eritage Crafts) sso#iation* hereafter referred to as the &C"%' or the &(C)'+

hese Rules shall !e!inding on all mem! ers of the C"%+ "f there is any #onfli#t* the Constitution shall ta, e \$re#eden#e+

2. Membership

- (1) Mem! ers are &"ndi-iduals and sole traders'* &.oint mem! ers'* &/tudents and trainees'* &"nstitutions and organisations'* &/mall #raft! usinesses' and &Oarger! usinesses and #om\$anies'+
- (2)) mem! er may ! e an indi-idual o-er si1teen* a #or\$orate ! ody* or an indi-idual or #or\$orate ! ody re\$resenting an organisation 2hi#h is not in#or\$orated+
- (3) he rustees
 - (a) may re4uire a\$\$li#ations for mem! ershi\$ to ! e made in any reasona! le 2ay that they de#ide5
 - (!) shall* if they a\$\$ro-e an a\$\$li#ation for mem! ershi\$* notify the a\$\$li#ant of their de#ision 2ithin 21 days5
 - (#) may refuse an a\$\$li#ation for mem! ershi\$ if they! elie-e that it is in the ! est interests of the C"% for them to do so5
 - (d) shall* if they de#ide to refuse an a\$\$li#ation for mem! ershi\$* gi-e the a\$\$li#ant their reasons for doing so* 2ithin 21 days of the de#ision! eing ta, en* and gi-e the a\$\$li#ant the o\$\$ortunity to a\$\$eal against the refusal5 and
 - (e) shall gi-e fair #onsideration to any su#h a\$\$eal* and shall inform the a\$\$li#ant of their de#ision*! ut any de#ision to #onfirm refusal of the a\$\$li#ation for mem! ershi\$ shall!! e final+
- (6) Mem! ershi\$ of the C"% #annot ! e transferred to anyone else e1#e\$t in the #ase of an indi-idual or #or\$orate ! ody re\$resenting an organisation 2hi#h is not in#or\$orated* 2hose mem! ershi\$ may ! e transferred ! y the unin#or\$orated organisation to a ne2 re\$resentati-e+ /u#h transfer of mem! ershi\$ does not ta, e effe#t until the C"% has re#ei-ed 2ritten notifi#ation of the transfer+
- (5) he C"% must #om\$ly 2ith its o! ligations under the 7eneral Regulations in relation to the , ee\$ing of* and \$ro-ision of a##ess to* registers of its mem! ers and #harity rustees+

- (8) (onorary Mem! ershi\$ of the (C) may ! e granted ! y a ma9ority of rustees* and may ! e for a \$eriod or for life+ (onorary Mem! ershi\$ falls under the #ategory of "ndi-idual Mem! ershi\$+
- (:) Mem! ershi\$ of the (C) is su! 9e#t to the re#ei\$t! y the (C) of the #orre#t mem! ershi\$ fee and runs for 12 months+

3. Termination of membership

- (1) Mem! ershi\$ of the C"% #omes to an end if:
 - (a) the mem! er dies* or* in the #ase of an organisation or #or\$orate! ody (or the re\$resentati-e of an organisation or #or\$orate! ody) that organisation or #or\$orate! ody #eases to e1ist5 or
 - (!) the mem! er sends a noti#e of resignation to the #harity rustees5 or
 - (#) any sum of money o2ed ! y the mem! er to the C"% is not \$aid in full on the due date5 or
 - (d) the #harity rustees de#ide that it is in the ! est interests of the C"% that the mem! er in 4uestion should ! e remo-ed from mem! ershi\$ and \$ass a resolution to that effe#t+
- (2) ; efore the #harity rustees ta, e any de#ision to remo-e someone from mem! ershi\$ of the C"% they must:
 - (a) inform the mem! er of the reasons 2hy it is \$ro\$osed to remo-e him* her or it from mem! ershi\$5
 - (!) gi-e the mem! er at least 21 #lear days< noti#e in 2hi#h to ma, e re\$resentations to the #harity rustees as to 2hy he* she or it should not! e remo-ed from mem! ershi\$5
 - (#) at a duly #onstituted meeting of the #harity rustees* #onsider 2hether or not the mem! er should ! e remo-ed from mem! ershi\$5
 - (d) #onsider at that meeting any re\$resentations 2hi#h the mem! er ma, es as to 2hy the mem! er should not ! e remo-ed5 and
 - (e) allo2 the mem! er* or the mem! er<s re\$resentati-e* to ma, e those re\$resentations in \$erson at that meeting* if the mem! er so #hooses+

4. Membership fees

- (1) he su! s#ri\$tion for mem! ers of the C"% shall ! e su#h a sum as may ! e determined ! y the rustees from time to time+ he first su! s#ri\$tion shall ! e on a\$\$li#ation for mem! ershi\$ and then due annually+
- (2) he rustees shall ha-e the \$o2er to #harge an entran#e fee to e-ents of the C"%* additional to a mem! er<s su! s#ri\$tion+

5. Trustees

(1) he rustees shall all ! e mem! ers of the C"%* and 2ill manage its affairs

and administer its funds+

- (2) he rustees shall not ! e less than 3 in num! er or e1#eed 15* in#luding the Chair* =i#e Chair* reasurer and /e#retary+
- (3))t e-ery third) nnual 7eneral meeting* the rustees shall \$ut themsel-es for2ard for re>ele#tion+
- (6)) mem! er of the C"% may \$ro\$ose or se#ond mem! ers for ele#tion as a rustee at the) nnual 7eneral Meeting+ Nominations must ! e gi-en to the /e#retary not less than 21 days ! efore the) nnual 7eneral Meeting+
- (5) he rustees may at any time de#ide to a\$\$oint a ne2 rustee* \$ro-ided that the ma1imum num! er of rustees 2ould not as a result! e e1#eed+?ersons so a\$\$ointed shall hold offi#e until the ne1t) nnual 7eneral Meeting after their a\$\$ointment and shall! e em\$o2ered to -ote+
- (8) he rustees may see, ad-i#e from ad-isors+
- (:) he rustees may a\$\$oint su! >#ommittees a##ounta! le to it for su#h \$ur\$oses as it determines+
- (8) he rustees may ma, e rules regulating the #ondu#t of meetings (other than general meetings)* attendan#e of -isitors* #harges for -isitors and other2ise for the regulation of the C"%<s affairs+
- (9) he rustees shall meet as re4uired and normally not less than four times a year+) 4uorum shall #onsist of at least one half of rustees* one of 2hom should! e an %ffi#er+

#. \$atrons

he rustees may in-ite u\$ to 10 \$ersons to ! e#ome ?atrons (in addition to the ?resident) in re#ognition of their ser-i#es and@or #ommitment to the o! 9e#ti-es of the C"%+ hese \$ositions shall !e for a \$eriod of u\$ to 3 years and may !e rene2ed for further 3 year terms+

- (2) he) nnual 7eneral Meeting shall !e held at su#h \$eriods as re4uired ! y the Constitution and at su#h time and \$la#e as determined ! y the rustees+ he ! usiness of the) nnual 7eneral Meeting shall !e to re#ei-e the e1amined annual statement of a##ounts and the rustees< annual re\$ort* and to ele#t rustees and %ffi#ers of the C"%+
- (3) %nly mem! ers are entitled to -ote+) n organisation or a #or\$orate! ody that is a mem! er of the C"% may* in a##ordan#e 2ith its usual de#ision>ma, ing \$ro#ess* authorise a \$erson to a#t as its re\$resentati-e at any general meeting of the C"%+ he re\$resentati-e is entitled to e1er#ise the same \$o2ers on! ehalf of the organisation or #or\$orate! ody as the organisation or #or\$orate! ody #ould e1er#ise as an indi-idual mem! er of the C"%+
- (6) he ele#tion of rustees and %ffi#ers shall !e! y a sho2 of hands of those entitled to -ote unless there are more #andidates than there are -a#an#ies to! e filled* in 2hi#h #ase the rele-ant ele#tion shall!e!y!allot of those entitled to -ote+
- (5) he 4uorum for general meetings shall ! e 6 mem! ers entitled to -ote or one t2entieth of the total mem! ershi\$ at the time* 2hi#he-er is the greater+
- (8)) Il general meetings other than the) nnual 7eneral Meeting shall ! e #alled general meetings+
- (:) he rustees must* 2ithin 21 days* #all a general meeting of the mem! ers of the C"% if they re#ei-e a re4uest to do so from at least 10D of the mem! ers of the C"% (or 5D if there has not ! een any general meeting of the C"% for more than 12 months)* and if the re4uest states the general nature of the ! usiness to ! e dealt 2ith at the meeting* and is authenti#ated ! y the mem! er(s) ma, ing the re4uest+) ny su#h re4uest may in#lude \$arti#ulars of a resolution that may \$ro\$erly ! e \$ro\$osed* and is intended to ! e \$ro\$osed* at the meeting+) ny general meeting #alled in this 2ay must ! e held 2ithin 28 days from the date on 2hi#h it is #alled+ "f the rustees fail to #om\$ly 2ith this o! ligation to #all a general meeting at the re4uest of its mem! ers* then the mem! ers 2ho re4uested the meeting may themsel-es #all a general meeting+

Noti#e of resolutions to !e! rought for2ard shall!e gi-en in 2riting to the /e#retary at least 21 days \$rior to the holding of a general meeting+) ny su#h resolution shall ha-e! een duly se#onded and shall!e set forth in the agenda 2ith the name of the \$ro\$oser and se#onder+/a-e 2ith the #onsent of the rustees* a resolution 2hi#h does not #om\$ly 2ith the foregoing may not!e \$ro\$osed at a general meeting+

 - (1) Mem! ers shall notify the C"% of any #hange of address+
 - (2) Mem! ers< details 2ill ! e \$ro#essed fairly and la2fully and in a##ordan#e 2ith the C"%<s legitimate a#ti-ities+
